Military Preference Application

This application is for hunting lottery preference for **Minnesota residents** who are currently serving in active military service, or who have served actively at any time during the past 24 months, received the purple heart or 100% service connected disability.

NOTE: Preference will be given to eligible applicants before lottery drawings are held. Eligible applicants must complete all the following process to be considered.

- 1) Apply for lottery (can be done at any [agent location](#) or [online](#)).
- 2) Complete this preference application.
- 3) Submit completed preference application to DNR address below **before** the lottery deadline.

Eligible Applicants: Qualified service members who have been issued a no-fee deer license do not need to apply for antlerless deer permits. Licenses are for either sex but you must apply for any special hunts before the antlerless/special hunt deadline (i.e., park hunts). Military preferences do not apply to group applications, unless the entire group is all qualified service members.

- (1) "qualified service member or veteran" means a Minnesota resident who is currently serving, or has served at any time during the past 24 months, in active service as a member of the United States armed forces, including the National Guard or other military reserves; and
- (2) "active service" means service defined under section [190.05, subdivision 5b or 5c](#).
- (3) Has received a Purple Heart medal for military service, as shown by official military record.
- (4) Has a service-connected disability rated at 100 percent as defined by United States Department of Veterans Affairs.

****This application does not apply** to licenses or permits for taking moose, elk, or prairie chickens. Individuals discharged within 24 months (outside the United States) need not apply for Spring Turkey lottery, please visit a license agent and purchase for free a #623-Military Spring Turkey/Discharged.**

All information requested on this application is required in order to obtain preference in lottery drawings. Incomplete applications will be excluded from obtaining preference.
