



# Application for a Prohibited Invasive Species Permit

Minnesota Department of Natural Resources (DNR)  
Division of Ecological and Water Resources

## Introduction and Instructions

### ***What are prohibited invasive species?***

In Minnesota, invasive species can be classified as prohibited or regulated. In general, you may not possess, import, purchase, sell, propagate, transport, or introduce prohibited invasive species (*Minnesota Statutes*, section 84D.05). Prohibited invasive species are listed in rule (*Minnesota Rules*, part 6216.0250) and [on the DNR's website](http://www.dnr.state.mn.us/invasives/laws.html) ([www.dnr.state.mn.us/invasives/laws.html](http://www.dnr.state.mn.us/invasives/laws.html)).

### ***Who needs this permit?***

You need to apply for this permit if you or your organization would like to possess, propagate, import, purchase or transport a prohibited invasive species for disposal, control, research or education.

- You may qualify for a general permit if you only want to possess preserved or herbarium specimens of certain prohibited invasive species. That general permit is available [on the DNR website](http://www.dnr.state.mn.us/invasives/ais_specimens.html) ([www.dnr.state.mn.us/invasives/ais\\_specimens.html](http://www.dnr.state.mn.us/invasives/ais_specimens.html)).

### ***Who can apply for this permit?***

To apply for a prohibited invasive species permit, you must be able to demonstrate that you have the skills, experience and facilities necessary to prevent the escape of invasive species. You must be at least 18 years of age, or, if you are applying on behalf of a corporation, limited partnership, or other business entity, that organization must be qualified to do business in Minnesota. The DNR may restrict permits for research and education on prohibited invasive species in areas of the state where those species have not yet been found.

### ***How do I apply?***

1. Complete the permit application on the next page; attach additional pages if necessary.
2. Submit your completed application by email or mail to your local DNR Invasive Species Specialist. You can find the invasive species specialist in your area from the [list of contacts and map on our website](http://www.dnr.state.mn.us/invasives/contacts.html) ([www.dnr.state.mn.us/invasives/contacts.html](http://www.dnr.state.mn.us/invasives/contacts.html)).
