Meeting Notes

Opening

Meeting called to order by Amber Westerbur, at 1:00 pm.

Coastal Program Evaluation "Workshop"

Amber went over the exercises to develop content for the Coastal Program evaluation, which is required from the Governor's Council, under the Program's Executive Order.

- Good, honest, and positive critiques of applications/effectiveness of grant selection earning Five votes
- Community acceptance/helping to effect meaningful and positive change up the shore earning Four votes
- New ranking system is better
- Assistance and availability of staff earning Four votes
- Enjoy learning history through storytelling, including place and people earning One vote
- Welcoming to newbies/good energy
- Food is good
- Open minded and learning new things
- Effective teamwork and collaboration/Powerful knowledge exchange earning Three votes
- Useful
- Strong sense of humor

Where can improvements be made to the Coastal Program

 Better communications about impact and outreach (actively encouraging people to apply for grants.) – earning Seven votes

- Better/different website
- Can we have formal tribal representatives? earning Five votes
- Lack of appointments have we had contact with county boards?
- More intentional recruitment for members (personal) earning Five votes
- Individuals apply but do not hear back about their application
- Virtual meeting not as effective as being in the room
- Additional advocacy of what is happening up here earning Two votes
- Miss having smaller grants earning Four votes
- More focus on TEK highly encouraged and not just more points on grant applications earning Two votes
 - Support traditional medicines (i.e. birch)
 - $\circ \quad \text{Doing more with wild rice} \\$
- Add the Nemadji River to our boundary

In Summary of the Coastal Program Evaluation Workshop:

After all of the votes were tallied, there were three topics that Council felt most important. Staff then went through those topics with Council:

- What can we do to ensure better communication?
 - o 0.5 time staff person or another DNR expert
 - $\circ\quad$ Add more photos to website different form of website
 - o Apply for Coastal Management fellow for communications
 - Better communications by having an event. (i.e. Coastal Conference), for the 25th Anniversary tabling at various events
- Ideas for more Tribal representation on the Coastal Council
 - Possibly changing the Executive Order to include other Tribes
 - Fond du Lac, Grand Portage, At-Large
- Ideas for more Intentional Recruitment
 - o Need someone in the governor's office to help with recruitment
 - \circ $\;$ A really good orientation about council and its expectation
 - Longevity means a lot
 - Appointments need to be longer. Two to three years, staggered.
 - The process needs to be better
 - Website needs to be better
 - go outside the DNR
 - add more photos
 - Make re-application to the Council easier
 - o Council members need to be the point of contact at the table during conferences/conventions
 - Testimonial and quotes from existing Council members to positive statements too

Program Managers Report

- NOAA has accepted the 2023 Performance Measures report hit most of the 5-year targets.
- 25th Anniversary of the Coastal Program planning.
 - \circ $\;$ Thinking on the lines of a year-long celebration of smaller events
- Making progress on developing the cooperative agreement.
